In the Philequity Electronic Statement & Electronic Confirmation Facilities User Agreement ("Agreement"), "you", "your" or "yours" refer to any shareholder of any of the mutual funds managed by Philequity Management, Inc. ("PEMI") and additionally, in the case of Electronic Statement & Electronic Confirmation Facilities, Electronic Statement & Electronic Confirmation Facilities Password and "we", "us" and "our", "PEMI" and "Philequity" refer to Philequity Management, Inc.

GENERAL TERMS AND CONDITIONS

In consideration of our agreement to provide Philequity Electronic Statement & Electronic Confirmation Facilities, you agree that:

1. **ACCEPTANCE.** By using Philequity Electronic Statement & Electronic Confirmation Facilities, you have accepted and agreed to be bound by all operational rules and general terms and conditions governing Philequity Electronic Statement & Electronic Confirmation Facilities, including without limitation all the following paragraphs and to pay any fee associated with the use of Philequity Electronic Statement & Electronic Confirmation Facilities. You likewise agree to be bound by any and all laws, rules, regulations and official issuance applicable to Philequity Electronic Statement & Electronic Confirmation Facilities, now existing or which may hereinafter be enacted, issued or enforced, as well as such other terms and conditions governing the use of other facilities, benefits or services we may from time to time make available to you in connection with Philequity Electronic Statement & Electronic Confirmation Facilities.

3. **ENROLLMENT.** You shall enroll in Philequity Electronic Statement & Electronic Confirmation Facilities and provide the e-mail address before you are allowed to use Philequity Electronic Statement & Electronic Confirmation Facilities. Your Statements of Account and Confirmation Notices will be delivered to you as an attachment in an e-mail using the e-mail address you have provided. You may gain access to Philequity Electronic Statement & Electronic Confirmation Facilities through the use of your Password or such other means of identification assigned to you in connection with your Accounts. 4. **RESPONSIBILITY.** You authorize us to act only upon any written instructions pertinent to Philequity Electronic Statement & Electronic Confirmation Facilities which have been duly signed by you. We shall be responsible for acting only on those instructions which are actually received and you agree that we do not assume any responsibility for malfunctions in communications facilities not under our control that may affect the timeliness or accuracy of the instructions sent. Such instructions including enrollment, cancellation, change in Electronic Statement & Electronic Confirmation Facilities Password, change in e-mail address, shall be upon receipt by us be effected at our absolute discretion. We shall neither be liable for acting upon such instructions sent nor be obliged to investigate the authenticity or authority of persons effecting your instructions or verify the accuracy and completeness of your instructions. Such instructions shall be deemed correct, complete, irrevocable and binding upon our receipt. We shall be entitled but not obliged to verify any instructions by sending e-mail or via telephone or any other means. 5. **SUSPENSION/CANCELLATION.** We have the absolute discretion to make the Philequity Electronic Statement & Electronic Confirmation Facilities available to you. We have the discretion from time to time to modify, restrict, withdraw, cancel, suspend or discontinue Philequity Electronic Statement & Electronic Confirmation Facilities without giving any reason therefore. You understand that by using the Philequity Electronic Statement & Electronic Confirmation Facilities after any modification or change has been effected, you have agreed to such modification or change. You shall likewise have the right to cancel your enrollment in Philequity Electronic Statement & Electronic Confirmation Facilities provided you give prior notice of such cancellation, through a letter of instruction sent to us and we acknowledge receipt of such notice. Upon cancellation of your enrollment, we shall automatically generate the paper form of your Statements of Account and Confirmation Notices and send to your mailing address the paper form of your enrolled Statements of Account and Confirmation Notices on the next statement date.
6. **UNAUTHORIZED USE.** You are responsible for keeping the Electronic Statement & Electronic Confirmation Facilities Password secret and confidential and you shall not disclose the Electronic Statement & Electronic Confirmation Facilities Password to any unauthorized person and shall take all steps necessary to prevent discovery of the Electronic Statement & Electronic Confirmation Facilities Password by any unauthorized person. You shall inform us as soon as reasonably practicable if you know or suspect that someone else knows the Electronic Statement & Electronic Confirmation Facilities Password or that the Electronic Statement & Electronic Confirmation Facilities Password have been lost or stolen and if you fail to do so you shall be liable for any unauthorized viewing done. You shall promptly view and examine your Statements of Account and Confirmation Notices upon availability and if you discover any discrepancies, omissions, inaccuracies or incorrect entries, you must immediately call PEMI within five (5) banking days upon discovery. You shall be liable for all losses prior to your reporting any discrepancies, omissions, inaccuracies or incorrect entries or if you act fraudulently or with gross negligence, including failing to properly safeguard the Electronic Statement & Electronic Confirmation Facilities Password or immediately report any unauthorized transaction made.
7. **INDEMNIFICATION.** We shall not be liable for, and you agree to indemnify and keep us indemnified, against any and all proceedings, claims, losses, damages or expenses (including legal costs) arising from or in connection with the following:

(a) Our action upon any instructions which are identified by any use of your Electronic Statement & Electronic Confirmation Facilities Password;

(b) The improper or unauthorized use of Philequity Electronic Statement & Electronic Confirmation Facilities by any person other than the account holder.

(c) Any damage to the customer terminal, related facilities or software as a result of any access to Philequity Electronic Statement & Electronic Confirmation Facilities through your Electronic Statement & Electronic Confirmation Facilities Password;

9. **SECURITY.** We shall use reasonable effort to ensure that Philequity Electronic Statement & Electronic Confirmation Facilities are secure and cannot be accessed by unauthorized third parties. However, we do not warrant the security, secrecy or confidentiality of any information transmitted through any relevant internet service provider, network system or such other equivalent system in any jurisdiction via Philequity Electronic Statement & Electronic Confirmation Facilities.
